

TERMS AND CONDITIONS FOR THE DINERS CLUB SIMOLA HOTEL, COUNTRY CLUB AND SPA PROMOTIONAL COMPETITION CONDUCTED BY DINERS CLUB S.A (PROPRIETARY) LIMITED (“THE PROMOTER”)

1 How to Play

- 1.1 This promotional competition commences on Monday 6 July 2010 and terminates on Friday 13 August 2010.
- 1.2 To qualify as an entrant into this promotional competition you must:
 - 1.2.1 be a valid accountholder with the Promoter in your personal capacity (“Card Account”);
 - 1.2.2 not have breached any of the terms and conditions applicable to your Card Account (including but not limited to being in arrears and/or over your credit limit) at the time of the lucky draw;
 - 1.2.3 visit the Promoter’s website found at www.dinersclub.co.za (“the Website”);
 - 1.2.4 complete the electronic entry form found on the Website by completing all the necessary information; and
 - 1.2.5 click onto the word ‘submit’ and submit your completed electronic entry form found on the Website (“Requirement”).
- 1.3 You will automatically be entered into the lucky draw when you successfully complete the Requirement.
- 1.4 Entry is limited to 1 (one) entry per entrant.

2 Prize

- 2.1 1 (one) entrant stands a chance to win a 2 (two) -nights stay at the Simola Hotel, Country Club and Spa in Knysna (“Hotel”) valued at R30 000.00 (thirty thousand rand) (“Prize”) which consists of the following:
 - 2.1.1 2 (two) -nights accommodation for 2 (two) adults sharing in a luxury suite including breakfast daily;
 - 2.1.2 champagne and a platter of fresh sushi upon arrival at the Hotel;

- 2.1.3 a round of golf for 2 (two) adults;
- 2.1.4 a picnic for 2 (two) adults;
- 2.1.5 a spa treatment for 2 (two) adults consisting of a Simola skincare ritual, massage, manicure, pedicure and Indian head massage;

 - 2.2.1 local flights to and from George Airport;
 - 2.2.2 travel insurance covering personal accident, medical expenses, emergency repatriation, baggage loss and loss of funds; and

4. GENERAL

- 4.1 The Promoter of this promotional competition is Diners Club S.A (Proprietary) Limited ("the Promoter").
- 4.2 The Promoter, its directors, members, partners, employees, agents or consultants and their spouses, life partners, parents, children, siblings, business partners or associates are not eligible to participate in or enter the promotional competition.

- 4.4 All information relating to this promotional competition and published on any promotional or advertising material forms part of these terms and conditions of entry.
